OTHER REPORTS

Supervisor Riester reported that the sales tax collected for the month of November was \$114,646.50. This is compared to \$112,618.05 for November 2012, an increase of \$2,028.45. The year to date total received is \$1,462,379.34, which is an increase of \$80,471.92 from 2012. Supervisor Riester also reported that he and the Assessor have been making phone calls to residents that have not refiled for the BASIC star exemptions (required by New York State) by the December 31st deadline. Assessor Coughlin came in for an evening to help people with the online registration and she has also "walked" people through the process over the phone. He also reported that the Town has been awarded \$9,100.00 for the recycling bins purchased 5 years ago. A file has been started for the large recycling totes recently purchased when grant funds become available all the necessary documentation will be in one place.

Councilman Leible reported that the Building Department issued 8 violations in the month of December and 16 remain outstanding for the year. They also issued 6 building permits. The revenue received for the permits was \$60.00. The Highway Department has been busy plowing, salting and repairing equipment.

Councilman Morrison reported that the Sewer Department responded to 7 regular time sewer calls and 5 overtime calls. He also reported that to date they have installed 269 of the grant funded updates and cleaned 10 duplex tanks. The Water Department did a water push under Campbell Blvd. for a new install, repaired a water line that froze at the water tower, they filled the ice rink with water 6 water meter installs, delivered 9 recycling totes, and helped out in the Highway Department as needed. He also reported the Farmer's Market meeting was canceled in December due to weather. He reported that Sun King is the company of choice with the best overall deal for the Town for the pick-up and removal of electronics collected. The company will provide 18 pallets at no charge, free shrink wrap, free boxes and free pick up of the wrapped pallets. The Town will be paid \$.05 per pound. The Attorney has reviewed the contract and has proposed a couple of minor changes.
