ASSIGNMENT OF ANNUAL AUDITS

Chief Fiscal Officer Town Clerk-Tax Collector Judge Maziarz Judge Murphy Morrison Fischer Leible Jarvis Water/Sewer Clerks Leible

Councilman Leible reported that the Building Department issued 8 violations in the month of December and 5 remain outstanding, a total of 12 remain outstanding for the year. The Building Department also issued 9 building permits for a total revenue of \$1,290.00 for the month of December.

Councilman Fischer reported that the Sewer Department had 11 regular time sewer calls and 4 overtime sewer calls, 2 sewer curb boxes repaired, 2 partial updates were completed, 20 exchanges of medium to large recycle totes, 4 totes delivered to new homes, repaired grinder pumps, inspected pump stations, 14 gravity infiltration repairs and 6 manholes were relined. He also reported that the Water Department made 7 final reads, 2 sold home inspections, 3 open water and sewer trench inspections, 4 new home meters installed, filled ice rink, 1 frozen water meter replaced, 1 repair water curb box, 24 underground utility stakeouts completed. Some helped out with plowing when needed.

Engineer Britton reported that he spoke with the director from FEMA and they anticipate a target date of December to initiate the remapping of the Town. At that point the process will take approximately 1.5 years to complete. He also reported that the Dept. of Transportation and Niagara County are working on a project to include shoulder and drainage improvements and to widen Feigle Rd. The Town is also proposing the same roadway restoration for Fisk Rd. The funding for that road will be applied through the Greater Buffalo Niagara Regional Transportation Committee.
