Councilman Morrison also reviewed with the Board hiring a recreation director. Money was put in the budget for the position. He recommends the Board consider hiring someone because of the increase in paper work for the summer program, following the states guidelines for hiring enough supervision, the ice skating program. He also updated the Board about some of the ideas the Farmer's Market has been considering, such as purchasing their own bounce house and possibly a dunk tank to bring more people to the market.

Water-Sewer Superintendent Argo reported that the owner of property at 4567 Mapleton Rd. (located in a Light Industrial zone) would like to have a waterline installed to this vacant lot. He is hoping to have a tree farm on this lot and would pay for the line himself.
