### TOWN OF PENDLETON Work Session

May 31, 2017

A work session of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, N.Y. on the  $31^{\rm st}$  day of May, 2017. The meeting was scheduled for 7:00 P.M.

Supervisor Maerten opened the meeting at 7:08 P.M.

Supervisor Maerten, Councilman Fischer, Councilman Ostrowski, Councilman Leible were present. Councilwoman Jarvis was absent. Also present:

There were approximately 10 residents in attendance.

Mr. Braunscheidel spoke to the Town Board regarding a drainage easement he signed 49 years ago when he first moved into the Creekview subdivision. He recently met with the Board of Appeals for a request to construct an addition to an existing accessory structure that would run three foot across the easement so his request was denied. He showed the Board a letter from Highway Superintendent Stowell that the easement at his end of the subdivision was not needed and has never been used by the Town for any reason. After a brief discussion it was determined that the easement was not necessary and Mr. Braunscheidel's Attorney could draw up the paperwork to release the easement.
