TOWN OF PENDLETON Work Session

October 5, 2015

A work session of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, N.Y. on the 5th day of October 2015. The meeting was scheduled for 7:00 P.M. Supervisor Riester, Councilman Leible, Councilman Morrison, Councilman Fischer, Councilwoman Jarvis, Clerk Pienta, Water-Sewer Superintendent Argo, Don Bergman, Budget Officer and approximately 5 residents were in attendance.

Supervisor Riester called the meeting to order at 7:04 P.M.

Carol Moeller from the Historical Society and the Board briefly discussed the plans for a citizen center. All were in agreement with the current drawing with the exception of the door for the Historical Society Office. Supervisor Riester will get in touch with the Frizlen Group to produce a set of enlarged plans for public review. Once the plans are received a couple of Public Informational Meetings will be scheduled.

A resident from Fisk Road reported to the Board the conditions of the road, the safety issues and the dangers of the various potholes and broken down edges of the road. Supervisor Riester explained that the Highway Superintendent has requested additional funds for that road. Fisk Road is on a list for a major over hall (state funds) but has not been selected yet. Feigle Road was on the list and approved several years ago. Construction on that is scheduled to begin in 2016. The Town is hoping that Fisk Road will be up for approval in April 2016. However if the road is approved, the work would not begin for several years, which is why Superintendent Stowell would like to invest enough time and money for the road to hold up until construction would begin.

The Town Board recently received a request from the Tonawanda Sportsman Club (TSC) for their approval for extended hours for shooting. It was referred to the Town Attorney for clarification regarding the Town Code. Attorney Joerg reported that the Town Code (§247-38 (F) clearly states that "Shooting hours shall be restricted to 10:00 a.m. to sunset. Extra hours shall be approved by the Town Board."
