

- 2. 5 contractor licenses were issued.
- 3. 20 visual inspections/meetings were conducted on site for various projects
- 4. Several violations were sent with 30 still outstanding to date. With several residents in court for various infractions.

For September we continued pressing on with the many projects we have ongoing in town as well as various other issues that have needed attention. There are a few hot button issues that have started to come to the surface that have taken a lot of time this month that we also are trying to attend to in order to handle them in the best way possible.

Neighbor issues still seem to be ongoing throughout town with various complaints coming in to the office that needed looking into, as well as some new business complaints that we are still investigating. We are hoping for a good solution for all but some are proving to be challenging.

Other items that occurred this month were gathering quotes and estimates for the budget proposal for next year and continuing to evaluate what processes can still change moving forward to help streamline the Building Department better. Jack also attended court dates regarding various resident infractions that were non-compliant.

I also attended a codes meeting with other Building Inspectors from the area on the 25<sup>th</sup> where I was able to get some feedback regarding some of the issues we face in Town and get some good feedback on how those situations were handled in other Towns. The meetings prove to be very informative in helping learn from other Inspectors experiences.
