#### **PENDING APPROVAL**

#### TOWN OF PENDLETON

July 13, 2020

A Regular Meeting of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, NY, on the 13th day of July 2020 at 7:00 p.m. Pursuant to Governor Cuomo's Executive Order 202.1, temporarily modifying the Open Meetings Law due to the COVID-19 pandemic and in the interest of public safety, the meeting was not open to the public. The meeting was conducted as a live GoToMeeting and a conference call line was provided to the public allowing access to live audio. The agenda and related documents were posted online and public remarks and comments were accepted until 6:30 p.m. on the night of the meeting. The audio recording of the meeting is posted on the town's website.

## WORK SESSION

Supervisor Maerten opened the Work Session at 7:09 p.m.

#### <u>Town Trails</u>

Councilman Evchich provided an update regarding recent conversations with the Trail Keepers. The Trail Keepers maintain the Erie Canal trails in the area which are the responsibility of the NYS Canal Corporation. He would like to have five or six Pendleton residents make up a local committee to help maintain our town trails. Councilman Evchich explained that his goal is to have our local committee perform the same kind of maintenance that the Trail Keepers do on the canal trails and assist them in this process. He also asked the others to be on the lookout for any funding opportunities that might be available.

Supervisor Maerten mentioned that the next round of funding for "Rails to Trails" should be opening this fall. He stated that our grant writers will continue to pursue funding for this.

Frontier Chemical Site on Townline Road

This discussion item was removed from the agenda and postponed.

## Additional Discussions

Supervisor Maerten stated that his goal is to have the August Regular Meeting open to the public. He asked Councilman Leible to check in to getting a constable to assist with the mandatory health screenings, etc. that will be required if we are open to the public.

Councilman Fischer reported that he recently spoke with a Cortland Drive resident who had concerns about the rash of illegal fireworks in the town over the recent months. Councilman Fischer asked if there was anything that could be done regarding this. Some of the other Board members remarked that this was a Statewide issue as well. The same resident also expressed concern over the use of golf carts and all-terrain vehicles (ATVs) in his subdivision and on the local trails. It was decided that the Niagara County Sheriff's Office should be notified of these issues for follow-up.

Councilman Fischer also mentioned that another resident contacted him with questions about the use of the park and pavilions. Supervisor Maerten explained that, due to a substantial loss of sales tax revenue as a result of the COVID-19 pandemic, the town does not have enough resources to be compliant with sanitizing protocol. He also remarked that other county and town parks are in the same situation.

Lastly, Mr. Fischer informed the Board that he is currently working with Bruce Culligan on the fire hydrant testing procedures for the fire company's Insurance Services Office (ISO) rating.

Councilman Evchich stated that Deputy Clerk Lemma brought up an idea to install hand sanitizer stations in the park. He felt it was a great idea and that Mason's Mission Foundation will be donating a hand sanitizer station.

Supervisor Maerten said that he sent information about bocce courts to Councilmen Graham and Evchich recommending that they share it with Recreation Director, Beatrice Mattina. He mentioned that this might be a good Eagle Scout project.

Councilman Graham reported that the tennis court and hockey area in Depeau Park is in need of repairs. The Recreation Committee had previously attempted to get quotes for resurfacing of these courts but that the repairs needed are much more than "blacktop sealing" of the surface. Money was allocated in the Parks and Recreation Fund of the 2020 budget for this project. He noted that Recreation Director Mattina is working on getting current quotes for this.

Councilman Graham also noted that the Tonawanda Creek Road construction project should be wrapping up soon.

Councilman Leible informed the Board that Justices Maziarz and Mack applied for a grant to cover the expenses of installing the barrier that was put in place in the court [COVID-19 protection].

The Work Session was called to an end at 7:30 p.m.

WHEREAS, it was determined that the Town's data network contains components that are in immediate need of replacement, repair, or upgrade as identified by the Town's information technology contractor, Niagara County Information Technology Department, during continued work being performed on the Town's data network; and

WHEREAS, it was deemed that knowingly operating a data network with compromised components posed a danger to Town operations and the residents served by the Town, therefore presenting an emergency situation; and

WHEREAS, such an emergency situation is outlined within the Town's adopted Procurement Policy, whereby the solicitation of multiple requests for proposals is not possible in a timely manner nor required;

NOW, THEREFORE BE IT RESOLVED by the Town Board of the Town of Pendleton on this 13<sup>th</sup> day of July 2020 that work performed by Armored Access Inc. was performed in an emergency situation to rectify network security issues and the payment of \$3,680.00 without solicitation of multiple requests for proposal was prudent and the amount shall be paid under the outlined circumstances.
