Niagara Military Affairs Council (NIMAC) Presentation

Supervisor Maerten welcomed Mr. Cooper and Mr. D'Aloise to the meeting. Mr. Cooper proceeded by giving a presentation to educate the Board on the importance of the Niagara Falls Air Reserve Station (NFARS). He explained that the mission of NIMAC is to support the growth and prosperity of the NFARS by creating a positive economic impact on our community. The presentation highlighted the impact NFARS has made on Western New York. The military investment from recent years and the future of NFARS were also discussed. Mr. Cooper explained that NIMAC relies on local support in addition to the State funding they receive. They already have relationships with many local municipalities and are asking for support from the Town of Pendleton.

Next, Supervisor Maerten, Budget Officer Bergman and Engineer Britton discussed the status of the final invoice payments and reimbursements for the Rails to Trails and Fisk Road Rehabilitation projects. It was decided at this time to add Voucher #11350 to Abstract #20, payable to Clark Patterson Lee (CPL), in the amount of \$121,892.80, to be paid on October 30, 2019.

Attorney Joerg provided an update to the Borrego Solar Systems, Inc. project. The Planning Board has given Borrego approval for their project. Mr. Joerg provided a bond to Borrego for their review and approval. Borrego returned the bond with multiple modifications. Attorney Joerg read through the revised bond. This bond contained the name Pendleton Solar 1, LLC, instead of Borrego Solar Systems, Inc. Also, the terms and conditions included in the new bond do not comply with those given with the Planning Board's approval or with Town Code. Attorney Joerg and the Town Board did not approve of the modifications made to the bond. A lengthy discussion also occurred regarding the Payment in Lieu of Taxes (PILOT) request for this project.
