The other three lots will be sold off as required by the owner, Mr. Urban. The property is located in a CO-2 Medium Commercially zoned area.

All questions from those in attendance were addressed so on a motion by John Higgins & seconded by Dave Naus the Public Hearing was closed at 7:45PM.

A motion was made by John Higgins & seconded by Dan Vivian to approve the minor subdivision conditioned on a proper survey & filing deed description with Niagara County within two years of today's date. All agreed.

5. Lombardo Three Lot Minor Subdivision - 4520 Beach Ridge Road

6. Secure Storage Site Sketch Review - 6886 S. Transit Road

The 5.2 acre proposed site plan sketch was reviewed by the PB for a storage facility at 6886 S. Transit Road. The site is located in a Medium Commercially Zoned Area (CO-2). The proposed action will convert the existing structure into a heated storage facility & build two additional cold storage facilities behind that structure.

The applicant revised sketch was reviewed by the Planning Board. The Planning Board Chair recommended the addition of a Knox Box to allow access by the Fire Department. The Town Engineer had no additional comments. The sketch will be sent out for coordination for coordination/comments to the appropriate Town offices.

7. Town Code Review

The Planning Board reviewed the administrative changes to the Town Code (Chap 247-73, 74, 75, 76, & 91) & unanimously issued a positive recommendation to the Town Board.
