FROM THE SUPERVISOR'S DESK

Another busy year is quickly fading into the past and I'd like to recognize all of those who have played a part this past year, no matter how small, in helping to make our town a great place to live. From the Town's employees, to the many members of boards and committees, to all of the community volunteers who participate with the many organizations in Pendleton, thank you all for your hard work and dedication to our community. There are many ups and downs associated with serving in an elected position, but I can say it's never too hard to find someone to help tackle a challenge or take-on a project. Thank you all for all you do!

Soon it will be January and the Town Board will hold its yearly reorganization meeting at the first regular meeting of 2020. I look forward to beginning a new year and working with Councilman-elect Jason Evchich and Councilman Dave Leible, who was re-elected to

another term. I'd also like to recognize Amanda Irons-Rindfleish who devoted a lot of effort to this fall's town board election. No one knows the stress and scrutiny faced by those running for office until you've actually stepped out into the public eye and campaigned for a position. Always hold your elected representatives accountable, but I can say from my own experience that it means a lot to also hear words of support. I often receive encouragement and thanks from the community and I thank those

who offer such support, as it means a lot.

This fall much of the Town Board's time was, as usual, consumed by the budgeting process. I'll provide greater detail in the first newsletter of January, but I can summarize the process as a constant attempt to meet a growing list of needs with a limited amount of revenue.

The bottom line is that the approved 2020 budget is under the tax cap and was crafted with a conservative approach to planning for expenses and anticipated revenue.

This fall the Town Board also had a very informative meeting with the leadership of the Wendelville Fire Company focused on the Fire Company's long-term needs, as the constant

growth in Town has translated to ever increasing demands on the Fire Company and its volunteer membership. For those who do not know, the Wendelville Fire Company provides fire, rescue, and emergency medical response for the entire Town of Pendleton and is staffed by well-trained volunteers. Financial support comes from the Town's budget and through community donations. As there will be more detail on the Town's budget in early 2020, I also intend to provide greater detail on the Fire Company's ongoing needs.

Speaking of the Fire Company and its sources of funds. I recently received in the mail a fundraising letter from the South Lockport Fire Company. As previously outlined, the Wendelville Fire Company is supported by Town of Pendleton residents through both the Town's budget and community donations. Also, since all volunteer fire companies are supported financially in the same way, it is unethical to attempt to fundraise in the response area of another volunteer fire company. I have attempted to address this with the leadership of the South Lockport Fire Company, both during my time as Fire Chief and also as Town Supervisor, yet they refuse to end this unprofessional activity. If anyone has questions about requests for support from local organizations, please feel free to contact the Town Hall with questions. Also, if you receive a request for donation related to emergency services, please keep in mind which organization is there, all day – everyday, ready to help you in your time of need.

To end on a positive note, I hope that all have a happy holiday season and a great start to the new year. As always, should you have any questions or concerns, please don't hesitate to contact the Town of Pendleton. Also, the Town's website is continually updated with information, so check often for new additions.

AN IMPORTANT MESSAGE ABOUT LICENSING YOUR DOG (S) As required by Article 7 of the New York State Agriculture and Markets Law, any dog four (4) months of age or older must be licensed within the town they reside in. The Town of Pendleton will be conducting a Dog Enumeration (census) beginning in the spring of 2020. Licensing your dog ensures that all dogs have been properly vaccinated against rabies for the protection of both you and your neighbors. It also helps to locate the owner of a lost dog when he or she is found. Please do not wait until the dog enumeration process begins to license your dog (s) as you may be charged an additional enumeration fee of \$25.00. IMPORTANT: If you pay your bills through your bank's online bill paying program, please make sure that you are sending them to the address stated above (we no longer use a PO Box). You will also need to allow enough time for your check to be mailed to and received at our office. The envelopes sent by your bank DO NOT have a USPS postmark that is stamped by the Post Office therefore it will be considered paid the day it is actually received in the office. The payment MUST BE received in the office by the due date in order to consider it a timely payment. (Real Property Tax Law §925.)

HIGHWAY DEPARTMENT

Hello, Another season has passed and I'm not sure which one it was. I'm not sure Mother Nature knows anymore either as the snow came in full force early in November. We're ready of course, not exactly. We were pretty well prepared for a light snow event but as time passed and the forecast seemed a little more sure it might be around a foot of snow I brought in 4 guys on Veteran's Day to put the rest of our trucks together. It's not an easy transition as most of the trucks we multi-task with so I try to use them for a lot of other jobs until I feel the snow is "really" coming. I'm very proud of my crew, especially our mechanic, Mike, for stepping up and getting everything ready then plowing and salting our roads.

We had some minor plow damage as we also put our plow guide stakes in throughout November. We always do minor plow damage to lawns and repair ASAP. Most times we put the sod back in place during melting conditions and when Spring rolls around you'd never know damage was done. That being said please use good judgment when you put things in the right-of-way that we cannot be responsible for (like lawn sprinklers, landscaping, etc.) and definitely anything that prevents us from plowing and pushing snow off the roads.

Reminder: It is illegal to place your snow into the roadways and it is definitely unsafe. Other than the basic "No Parking" laws please also try to allow our trucks to get through while you are clearing your driveways. We've had cases where my guys had to back the large trucks all the way out to the intersections.

Fisk Road construction was completed ahead of schedule and ultimately went very well. As a critic, I'm not real happy with the slightly bumpy ride but all in all, the project was a great improvement to a road that really needed a lot of work. Thanks to all, especially those who live on Fisk Road, for waiting patiently for the funding to come through. We also had a problem with some other road projects like the micro-seal on Meyer Road. Between weather and product failure we were unable to do any of the same work in Old Orchard Sub-division. The contractor and I will re-evaluate the roads that didn't perform well and come up with a plan to repair any roads as we roll into Spring and Summer 2020.

Due to weather and manpower issues we were only able to brush hog approximately 60% of our offroad ditches. Let's hope for dryer weather next year so we can get control of some of the main drainage ditches; especially some of those that we started to completely clean 10-15 years ago that now have trees in our way. I have talked to some of you about communicating with your own neighbors to help us. There are many years that our tractors can't get through to brush hog because many different items (firewood, fences, etc.) are placed in the easement preventing us from getting through. We need at least 20'along the side of the ditches free and clear in order to properly maintain them. Your help is appreciated. I think most of you know, as "flat" as Pendleton is, drainage is VERY important. My theory is, on average, ditches need to be cleaned and re-cleaned every 3 to 5 years. After getting control 10-15 years ago a lot of progress was lost during cuts in the Highway Department's manpower starting 12 years ago. This Town Board is doing everything they can to get us up to where we need to be. Obviously with the tremendous growth in Town there is much more work necessary to maintain everything from roads to parks.

As Christmas arrives (it's my favorite season) I hope in 2020 I can go back to being Clark Griswold. LOL Please enjoy your family and friends this holiday season and best wishes for good health and happiness. Jeff Stowell, *Highway Superintendent* jstowell@pendletonny.us (716)625-8033

* Please **do not** staple or paperclip your payment.

* Billing cycles occur quarterly in January, April, July and October.

* Water bills are mailed out by the last Friday of the billing month.

* If you do not receive a bill by the end of the first week of the following month please contact the billing department.

* For your convenience there is a lockbox located in the foyer at the back entrance to the Town Hall.

* If you pay online please allow <u>10 business days</u> for mailing.

If you are **selling** your home please contact the Public Works Department at 625-8033 as soon as possible to schedule a mandatory water/sewer line inspection. There is a \$50.00 fee for the inspection which will be added to your water/sewer bill. The inspection takes approximately 15 minutes to complete. You must have your water & sewer lines inspected before you sell your house!!!

When you receive your actual closing date, please contact the billing clerk at 625-8833, ext. 111 to schedule a final reading.

If you are **purchasing** a new home please contact our office ASAP to set up an account.

If you are leaving the area temporarily (i.e. Vacation) please be advised that the post office will not forward water bills, even if you have a forwarding

If your contact information changes (phone number and/or mailing address) please notify the billing department as soon as possible. We need updated contact information in case of an emergency situation.

the homepage click on **Departments** at the top of the page, scroll down and click on Water/Sewer, go to the right side of the page for Rates and Information.



Happy Holidays to my fellow town residents and families!! As we close another year in our local history book, let us remember those who have "blazed the trail" for us to reside, employ and work, learn and study, recreate, celebrate, and maintain our families in this GREAT place we call HOME. Generations of farmers, workers, teachers, business owners, service workers, medical personnel, and families have given of themselves, their time, and their varied resources to "grow" Pendleton.

For those of you who have lived here your entire lives, and your family before then, you remember how this town looked, felt, and operated. I wish I could have those memories because how cool it is that you played real "live" roles in shaping and reflecting on how it used to be.....how most of Pendleton consisted of farms. YOU are the story tellers to your loved ones, friends, and other residents.

Remember when there were only a few businesses about 50+ years ago? Remember Cappy's then Dutch's Deli where Uncle G's is now! Remember Pendleton Hardware where the Pendleton Pharmacy and other businesses in that plaza are now located! Remember when Fred's Pizza was Pat's Grocery store? And how Kandyland was the Convenient Store, which began as Horan's, for many years?! There was nothing but open land where Kenyons and Hebelers (opened in 1968) exist. Wendelville fire substation has been part of the five corners since 1969. Country Cottage has been around since 1948, and across the street from there on Beach Ridge was Dougherty's general store. A small five

and dime store existed across from Good Shepherd Parish years ago. Scooters was Kleins and then Greens in earlier days. There's Brauers Restaurant on Campbell Blvd. I have memories of Easter brunch there!! Do you? And don't forget all the FARMERS who worked these local lands for generations!!!

Well you will be intrigued to know that NOW we have nearly 150 local businesses!! If that doesn't convince you of our growth, then look at the houses built, subdivisions and new roads added, and the increase in student enrollment at Starpoint the past twenty years. Listing all these businesses would be monumental, but they include small businesses, restaurants, landscaping, pool, electrical, plumbing, and other home services, churches, recreational places, daycares, various contractors, car dealers, stores, ice cream shops, fitness places, manufacturers, medical services, repair shops, a golf club, an apple orchard, a sportsman club, hotels, and many more commercial endeavors!!!

If you move from your primary residence in Pendleton it is your obligation to notify the Assessor's Office. Each residence that is receiving the Star Exemption signed the Star Application acknowledging that they would notify the Assessor of their change in residency.

Please remember **all** exemptions are due by **March 1st**. If you will be turning 65 in 2020 you may be eligible for the Enhanced Star. If you believe you might be eligible, please call the Assessor's Office 625-8833 ext 116. If this is your **FIRST** time applying for Enhanced Star, then you will do so through our office. If you are switching to the **Star Credit Check**, then you do so online at www.tax.ny.gov or by calling (518) 457-2036.
