# PUBLIC HEARING – PROPOSAL TO TRANSFER FUNDS FROM HIGHWAY EQUIPMENT RESERVE

The notice for the Public Hearing was published in the Lockport Union Sun & Journal on January 8, 2020 and on the Town's website.

Supervisor Maerten opened the Public Hearing at 7:01 p.m.

The purpose of the hearing is for the transfer of \$216,000.00 from Highway Equipment Reserve (DA200.2) to Machinery Fixed Assets (DA5130.02), for the purchase of a 2020 Western Star 4700 Truck, a 2019 Everest Plow and a truck radio.

#### **OTHER REPORTS**

Councilman Fischer reported that in December the Highway Department plowed and salted roads, chipped brush, dug and repaired a bubbler on Hidden Oak, cleaned ditches and used the street sweeper in some of the subdivisions. They also repaired a 6" underdrain at a home on Arrowhead, installed pipe for hydrants on Fisk Road and repaired several areas from plow damage. Councilman Fischer also reported that he and Councilman Evchich completed the quarterly Length of Service Award Program (LOSAP) audit with the Wendelville Fire Company. He welcomed Councilman Evchich and offered support as he begins his first term as councilman.

Councilman Graham welcomed everyone to the meeting and wished them a Happy New Year. He congratulated Councilman Evchich and welcomed him to the Board. Next, Councilman Graham reported that the Sewer Department had 14 regular and eight overtime sewer calls in December. They updated three grinder systems, built one new sewer tap, unplugged one and repaired three sewer lines. The Sewer Department also completed 53 stakeouts, replaced a vacuum pump at the KeyBank lift station and rebuilt an E-One pump. He then reported that the Water Department completed three water/sewer compliance inspections, repaired two hydrants that were damaged by cars, pulled meters from two homes that were foreclosed on and repaired a water break on Mapleton Road. Also, three final reads were completed, a new build water tap was installed and the quarterly meter reading was completed. Councilman Graham continued his remarks by addressing the reappointment of members to the town's boards and committees. Past practice has been to reappoint current members, however, he noted that the Town is growing and changing and can sometimes benefit from "new eyes". There are some changes this year and wanted everyone to know that the decisions of the Board aren't taken lightly. They are well thought through decisions. Councilman Graham thanked everyone for their service and said that the Board appreciates the work that everyone has done during their term on the various boards and committees.

**Councilman Evchich** thanked his wife for the courage to run for office, thanked the audience for their support and asked for patience as he learns his role on the Board. He stated that he is here to work and is looking forward to hearing concerns from the residents as well as feedback on things they think are going well in the town.

**Attorney Joerg** had nothing to report at this time.

**Engineer Britton** reported that he has been working diligently with John Lavrich on pending code updates. He explained the process and stated that he will bring information to the upcoming Work Session to present to the Board for review.

**Budget Office Bergman** reported that he is working on the transfers for the accounts that were over budget and that he is preparing the year-end reports for the accountants that will be here in March.

# **DEPARTMENT HEADS**

**Town Clerk Maurer** reminded everyone that all oaths must be signed as soon as possible. She has already received signed oaths from each elected official but all individuals that were appointed as of this meeting will be required to file their oath by February 12<sup>th</sup>. Town Clerk Maurer also stated that year-end and monthly reports were submitted by the Town Clerk's office, the Building Department and the Water Billing Clerk and provided to the Board Members for their review. Next, she informed certain Board members and appointed employees that they will be required to submit a new Record of Activity (ROA) or a renewal for their New York State and Local Retirement System (NYSLRS) benefits. Finally, Town Clerk Maurer provided news from her office by stating that water bills can now be paid online. She hopes to have the registration for the Summer Recreation Program available online this year as well and informed the audience that she is pursuing approval for the Town of Pendleton to be a Passport Acceptance Agency in 2020.

**Building Inspector Diedrich** said that 2019 was a great year stating that there has been a lot of activity in the town. He provided a report with the statistics from December stating that six building permits and 20 contractor licenses were issued. He confirmed that 54 building permit projects have been completed and 66 visual on-site inspections were completed. The Building Department also sent two violations, has 19 open complaints, closed five complaints due to compliance and have two residents with pending court cases. He also noted that the Building Department has moved down the hall and merged with the Assessor's Office.
