## **TOWN OF PENDLETON**

November 7, 2019

A Special Meeting of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, NY, on the 7<sup>th</sup> day of November 2019 at 7:00 p.m. A Public Hearing was scheduled for 7:00 p.m. for the proposed 2020 Preliminary Budget. The notice of the Public Hearing was published in the Lockport Union Sun & Journal on November 1, 2019 and on the Town's website.

### **PUBLIC HEARING**

Supervisor Maerten opened the Public Hearing at 7:12 p.m.

Budget Director Bergman reviewed the Preliminary Budget line by line allowing for any questions or comments after each section of the Budget. He explained each of the increases or decreases allowing for questions after each section.

  - Water Billing Clerk Dispenza asked a question about the Levy Fee that was answered by Mr. Bergman
