HOME RULE REQUEST - MAPLETON ROAD

WHEREAS it is the duty of the Town Board of the Town of Pendleton to be proactive in identifying and addressing matters related to the safe travel of vehicles on roads located within the Town; and

WHEREAS concerns related to the speed and volume of traffic on Mapleton Road between the intersections of Campbell Boulevard and Townline Road have been conveyed to and received by the Town Board; and

WHEREAS appropriate requests for the evaluation of the posted speed limit on Mapleton Road have been submitted by resolution of the Town Board to the Niagara County Legislature and New York State Department of Transportation and subsequent evaluation has not provided the Town Board with the ability to modify such posted speed limits; and

WHEREAS further action to modify the posted speed limit by the Town Board of the Town of Pendleton may only result from approval of a home rule request by the New York State Senate and Assembly;

THEREFORE, BE IT RESOLVED that the Town Board formally requests home rule powers to modify, as necessary, the posted speed limit on any or all sections of Mapleton Road between the intersections of Campbell Boulevard and Townline Road.

Wheelchair Accessible Bathroom Update

Councilman Evchich provided an update on the construction of the wheelchair accessible bathroom. He noted that project started at the end of 2018 when Senator Ortt agreed to a \$97,000.00 grant. Of that \$97,000.00, \$25,000.00 went towards the addition to the playground leaving the balance to be put towards this bathroom upgrade. He also commented that Masons Mission's website receives messages regarding the need for the upgrade. Councilman Evchich presented the Board with blueprints and plans and provided a detailed explanation of the project. He expressed that he has some concerns about the timing required to complete this project by July 4th noting that it will take 4-6 weeks to ship and approximately one month to construct. There was a discussion about whether the Highway Department can construct it or if they will need to hire from the outside. He stated that he will discuss with Highway and Water/Sewer Superintendent Stowell. Councilman Evchich also presented a diagram of a proposed water park for the town.

Supervisor Maerten began a discussion with Deputy Highway Superintendent Walter regarding the purchase of two new trucks for the Highway Department. A lengthy discussion

occurred between Mr. Walter and the Board members regarding the necessity to replace trucks #2 and #11. Mr. Walter provided three written quotes for the purchase of these vehicles:

WHEREAS such an emergency situation is outlined within the Town's adopted Procurement Policy, whereby the solicitation of multiple requests for proposals is not possible in a timely manner nor required;

THEREFORE, BE IT RESOLVED that work performed by Armored Access Inc. was performed in an emergency situation to rectify network security issues and the payment of \$7,722.00 without solicitation of multiple requests for proposal was prudent and the amount shall be paid under the outlined circumstances.

Engineer Britton provided updates on the Dormitory Authority of the State of New York (DASNY) money for the generator and salt storage facilities and the status of the proposed updates to the Town Code. A very lengthy discussion also occurred regarding a New York Leak Detection survey conducted four months ago. Engineer Britton will be providing a proposal for an "unallocated water" audit due to the results of that survey.

Supervisor Maerten announced that a Regular Meeting will be held on Monday, February 10, 2020 at 7:00 p.m.

Public Remarks/Comments

A resident asked questions about the park bathrooms and commented on the appointment of the new member of the Conservation Advisory Council.
