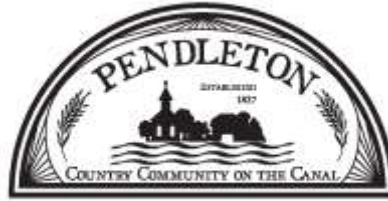

NOTICE OF PUBLIC HEARING**

PLEASE TAKE NOTICE that the Town Board of the Town of Pendleton will hold separate public hearings on the matters referred to, herein at the Town Hall, 6570 Campbell Boulevard, Pendleton, New York, on the 3rd day of November, 2021 at 7:00 p.m. Said public hearings shall be as follows:

1. Public Hearing on the preliminary budget for the fiscal year beginning January 1, 2022, as required by Town Law §108 for the purpose of considering the preliminary budget, and receiving comments from the public relative thereto. Said Budget is on file with the Town Clerk of the Town of Pendleton and may be inspected by any interested person. Office hours for the Town Hall are 8:00 a.m. to 4:00 p.m. The Preliminary Budget will also be located on the Town's website at www.pendletonny.us.

Pursuant to §108 of the Town Law, the proposed salaries of the following Town Officers are hereby specified as follows:

SUPERVISOR	\$	19,619.00
COUNCIL (4 @ \$7,936.00 each)	\$	31,744.00
TOWN CLERK	\$	57,366.00
SUPERINTENDENT OF HIGHWAYS	\$	52,014.00

2. A public hearing on amounts to be raised by taxation for Special Districts in the following districts:

PENDLETON WATER DISTRICTS	\$	470,384.00
PENDLETON REFUSE DISTRICT	\$	476,273.00
PENDLETON FIRE DISTRICT	\$	550,000.00

The Special Assessment Rolls have been completed for such districts as required and all tax rates established for benefit districts. All persons interested shall be heard at the public hearing to be held by the Town Board relative to assessments and amounts to be raised in said districts, and to hear any objections to the Special Assessment Rolls, which are available for inspection at the Town Clerk's Office.

3. A Public Hearing to authorize a contract with the Wendelville Fire Company, Inc. at a yearly amount as follows:
