From the Supervisor's Desk...

It's been a few years now that I've been writing quarterly newsletter articles and I'll be honest, I'm running out of new ideas of how to start an article in a unique way that will grab everyone's attention. However, there are a few exciting items to share, so I guess what I'll say is please read on. I'm pretty confident you won't be disappointed.

This fall the Town Board approved a contract with the Niagara County Sheriff's Office for a full-time Deputy Sheriff to be assigned exclusively to the Town of Pendleton. We have worked closely with the NCSO in recent years, addressing a wide-variety of resident concerns. However, with the rapid growth of the Town and other factors, there are limitations in what law enforcement can do on a dedicated basis to help address these concerns. This brought us to this point of working on an agreement to have a dedicated officer for the Town, a model that has been in place in the Town of Wheatfield for quite awhile.

As the year moves closely to an end, Sheriff Fillicetti is working to recruit an experienced NCSO deputy who will be solely focused on our Town's needs. We anticipate the officer to get to work getting to know the Town, residents, Town employees, the members of the Wendelville Fire Company, and others who this deputy will be working with on a regular basis. Additionally, the Town is home to the Starpoint School campus, which is populated by a large population of kids and adults and I personally will feel good knowing there will often be a trained responder nearby to respond to any calls for help.

To give you a basic understanding of the big picture, there will be no change to the number and frequency of NCSO and NYS Police patrols in the area. This extra patrol will increase the presence of law enforcement and will not be a replacement. The major factors influencing this move include concerns for roadway safety, crimes such as car break-ins, and general public safety. As we move through 2022 updates on this initiative will continue.

Another exciting bit of news is the anticipated construction of the new community center during 2022. This has been a topic for many years and through the award of grant funding and use of building fund reserves we are finally able to make this project a reality. The new building will be constructed where the current log cabin is located south of the Town Hall. Time has not been kind to the log cabin and it's condition is now such that it is not salvageable. Once completed, the new community center will have flexible space to be used by community groups conveniently located adjacent to the Town Park.

Also this coming year we anticipate construction of a new salt storage building and stand-by generator for the Public Works Facility. Though not as exciting as the two previous items, this project is equally important as our public works employees are often on the job when bad weather rolls in, presenting problems for all. The majority of the cost of this project is fortunately also covered by grant funding.

Another smaller project that will soon be underway includes upgrading of security systems in all Town buildings and the addition of more security cameras. Cameras currently located around buildings will be upgraded and new cameras will be located around the Town campus, including in the Town Park. The increase in NCSO patrols will certainly be an important component in safety and security on Town property, but cameras are also an essential

element as the number of people using the Town Park has increased significantly.

Winding this down, the Town Board recently approved the 2022 budget which is once again under the New York State tax cap. Though I outlined a lot of work taking place, the costs are



To all employees of the Public Works Department: A big thank you for pulling together and accomplishing all that we did this year. Your hard work is appreciated!



Hello and happy holidays! It has definitely been another trying year with continuous ups and downs due to the Covid pandemic. To say that it has changed the way we live and work is an understatement. We are constantly trying

to find ways to improve the services that we provide to our residents and welcome your feedback and suggestions.

By now you have noticed that your water bills are different. Some of you dislike the new format while others love it. In time these bills will seem as normal as the old postcard style did and we appreciate your patience Town Hall, Monday - Friday from 8:00 a.m. to 4:00 while you are getting used to this change. In the near future I hope to implement direct withdrawal options for those of you who are interested in this payment option.

I have included some important information for the upcoming months below.

The 2022 Recycling & Trash Collection calendar, which will include the Bulk Trash Pick-Up Schedule, will be mailed to all residents from Modern Disposal Services at the end of December. This can also be found on our website once it is released. This past year has been quite a transition for both residents and staff. We are working with Modern Disposal Service on a regular basis to help find ways to improve the service in the Town. In the meantime, here are some important tips to remember:

1.Only waste placed inside the cart is accepted. No bags, unless they are tagged.

2.Extra bag tags can be purchased at the Town Clerk's office for \$5.00 each.

3.Additional tote/refuse service can also be purchased for an annual fee of \$55.00.

4.Bulk trash is collected once per month. Each parcel is allowed a maximum of three items. (See schedule below)

The envelopes sent by your bank do not have a USPS postmark that is stamped by the Post Office therefore it will be considered paid the day it is actually received in the office. The payment must be received in the office by the due date in order to consider it a timely payment. (Real Property Tax Law §925.)






INTERESTING FACTS ABOUT EVERGREEN TREES

- Evergreens are year-round trees meaning they keep their leaves all year.
- Not just pines are evergreen. Any plant that keeps its leaves every season is classified as an evergreen.
- Thousands of different species of trees are considered evergreens.
- Some species of evergreens are fir, holly, redwood, pine, laurel, juniper, hemlock and palm trees.
- There is no specific color of an evergreen. For example, a palm tree typically has a brown trunk with green palms. A Blue Spruce, which is also an evergreen, has a brown trunk as well, but has silver-blue needles.
- Evergreen trees live on every continent except Antarctica.
- It is a popular belief that evergreens live best in cooler forests but they can thrive anywhere.

NEWS FROM NIAGARA COUNTY

As I write this, Niagara County is deep into its annual budget process. I am happy to say that our tentative budget is looking very good. Right now, the proposed budget would reduce the tax rate by 4.4 percent per \$1,000 of assessed valuation.



We would be at the lowest rate at least since Niagara County moved from a Board of Supervisors to a Legislature form of government 50 years ago. The overall budget stays under the tax cap for the 11th straight year, something that we have worked very hard to maintain.

The county budget is always under pressure from unfunded state mandates, which are demands New York State puts on the county and then expects us to fund. The New York State Association of Counties (NYSAC) even launched an advocacy effort on this issue, called the "9 for 90 Campaign." This effort highlights the fact that just nine state mandates could potentially consume 90 percent or more of county property tax levies statewide. In Niagara County, these nine mandates account for nearly \$74 million of our total tax levy of \$88 million, which is 92 percent.

Thankfully, our sales tax revenue has continued to rebound from the pandemic. Niagara County business activity has been increasing throughout 2021 and we

expect to see that continue next year. The budget plans for a \$2.9 million increase in sales tax revenue, about four percent. This year, we continue to maintain a fund balance equivalent to six percent of our budget as well as \$200,000 in a contingency fund. We always want to be in a position where we can weather the unexpected, as happened during the beginning of the pandemic.

I want to acknowledge the great work of the Niagara County Department of Public Works during the last construction season. First, there was the early summer storm that did significant damage to West Canal Marina Park. Thankfully, our crews were able to salvage many of the trees.

There was significant road work, particularly on Bear Ridge Road. The bridge between Irish and West Canal was replaced, and work was done on a culvert south of the Bear Ridge/Campbell intersection. Also, significant paving work was completed. I want to thank the public for their patience as roads were closed or reduced to one lane. We are a growing community with much more traffic on our roads which means we need to continue to invest in maintaining them to ensure safety and traffic flow.

Speaking of safety, I want to update on the DPW traffic study regarding the intersection of Bear Ridge and Tonawanda Creek. Wendel Architects and Engineers was hired to perform that traffic study and make any recommendations on how to improve the intersection. As soon as the county has the final report, I will be sure to make it public so the community can express their views.

There are no words to describe the seriousness of the fate that had befallen Miss Sarah Mumford. Her individual thread was cut short by the fates of antiquity in the prime of her life. Who was Sarah Mumford? What brought her to Pendleton?

Sarah was born in 1883. It is suggested, by historical documents, between Monroe and Wayne Counties. She had sisters and according to the 1892 census, there was three young ladies in close proximity: Grace, Kittie and Satie.

On April 22, 1895, Sarah (also known as Mary Ross) was adopted by a well-to-do Pendleton family from the Rochester Orphan Asylum. John Calder, bookkeeper for the Rochester Common Council, was in charge of the paperwork for the adoption. Sarah's mother was resident of the neighboring Rochester State Hospital. Cora Mumford is listed as a patient at this facility and seems to fit the description. Sarah's father had passed sometime before.

She had siblings via adoption: two brothers and a sister (one brother which preceded Sarah in life and in death many years before). A familiar face on the Pendleton farm, she was large for her age and attended school for a time. This was her home for the next four short years.

On Thursday June 8th 1899, Sarah was reported

missing by her adoptive father. According to eyewitness testimony, Sarah left the house around 9 p.m. bareheaded. A search party was assembled and spent the next several hours in vain. In the early morning hours of June 9th, Charles Bliss discovered Sarah's body at Sweeney Crossing on the Shawnee train tracks. She was 16 years of age.

The murder mystery was a shock to Victorian sensibilities yet it was best mulled over the daily periodical and a hearty breakfast. The news certainly permeated Erie County, Genesee and other areas nearby. In fact, one could find articles about the slaying as far south as Martinsburg, West Virginia.

The adoptive kin was arrested and housed at the Niagara County jail. A trial was declared null and void when the jury reached a "no bill" verdict. No one was charged with the crime and it remains unsolved to this day.

The modern day (ongoing) search party for the origins of Sarah Mumford would have not been possible without: Nancy Pritchard, Larry Naukam, Jerry Miller or Laura Prosser-McCabe, and many others. Ms. Prosser-McCabe is the devoted keeper of Miss Mumford's grave. After years of neglect, it's black patina was removed to reveal a dazzling white. It is a marvel to behold in the daylight. Rest peacefully, sweet Sarah.

Please remember **all** exemptions are due **by March 1st**. If you will be turning 65 in 2021 you may be eligible for the Enhanced Star. If you believe you might be eligible please call the Assessor's office 625-8833 ext. 131. If this is your **FIRST** time applying for Enhanced Star, then you will do so through our office. If you are switching to the **Star Credit Check**, then you do so online at www.tax.ny.gov or by calling (518) 457-2036.

Anyone receiving the Enhanced Star including Aged exemption recipients must now be Enrolled in the <u>mandatory</u> New York State Income Verification Program (IVP)
