Next, Supervisor Maerten spoke about Deputy Sheriff Kroening, recently assigned to the Town, stating that he has been very busy issuing traffic tickets to individuals, mostly non-residents, speeding through town as well as engaging with residents, the Town Hall staff, and the fire company membership.

#### **OTHER REPORTS**

**Councilman Graham** welcomed newly elected Councilman Hickman. He said that he is looking forward to working with him.

**Councilman Evchich** also welcomed Councilman Hickman and congratulated Highway/Water & Sewer Superintendent Fischer. He reported that he recently spoke with Recreation Director Bea Mattina saying that she will follow up with him once she hears back from Starpoint and Niagara County Department of Health regarding the 2022 Summer Recreation Program. He also stated that he has revised the Town's Facility Usage Agreement and will share that with the Board for approval.

**Councilman Hickman** thanked the voters for their support and said that he is looking forward to working with the residents of the Town of Pendleton and with the Board.

Town Attorney Joerg had nothing specific to report at this time.

Engineer Britton had nothing to report.

## **DEPARTMENT HEADS**

**Town Clerk Maurer** reported that passport assistance has been increasing and that her office passed their first federal audit of the passport process. She also reminded the elected and appointed officials that they will need to sign an oath of office within 30 days of appointment. She reported that the tax bills were mailed out at the end of December. Taxes can be paid in person at the Town Hall, or by placing them in the dropbox located at the back entrance. They can also be paid by mail or online. She also mentioned that water bills will be mailed out soon and that residents should note that they now have a PIN that will be listed next to their account number, which is only needed if paying online. Finally, she said that she is working on getting an automated payment option set up for future bills.

**Highway and Water/Sewer Superintendent Fischer** thanked former Superintendent Craig Walter for staying on a bit longer to help him transition into this position. A discussion also occurred regarding the renting of pavilions and it was determined that they could resume this process again in 2022. He also reported that the Public Works staff has been busy cleaning up the yard to make room for the new salt shed. Mr. Fischer also wanted to assure residents that these employees are hardworking and dedicated employees.

**Building Inspector Diedrich** reported that the Building Department has been unusually busy for this time of year. He has already approved many building permits and contractor license renewals. He also asked for an update on the Historical Society's request for a storage shed. He was told that they could hopefully approve this purchase at the Work Session later in the month. He also mentioned that he has been getting complaints about a business on the corner of Mapleton and Campbell and is working with the owner to resolve the issues there.
