POOL PERMIT APPLICATION

Any pool that is capable of containing more than 24" of water requires a permit. Any contractor installing pools within the town limits is required to be licensed with the Town of Pendleton.

POOL PERMIT REQUIREMENTS

1. Completed Pool Permit Application packet, with survey of existing property, showing approximate position of pool on property.
2. If the pool will require a separate fence, provide fence details, and also inform the office if the fence will be done at the same time by the installer or by a separate contractor.
3. A copy of a brochure from the pool manufacturer showing the make and model of pool.
4. All in ground and above ground pools require an electrical permit to be in place before the Permit will be issued.
5. Total cost of project.
6. NOTICE – Above Ground and In Ground Pool Permits are only valid for 90 days after issuance. The pool must be completed to the satisfaction of the code requirements as stated in the New York Fire Prevention and Building Code. This includes all permanent Barriers.
7. INSPECTIONS
 1. Inspection for height of pool or fence, alarm test.
 2. Final, after electrical final has been done and approved.

Please be aware that:

If either an Above Ground or In Ground Pool installation exceeds specified time limit on the permit, and is not completed and inspected for compliance, a violation notice may be sent to you.

I UNDERSTAND THAT UNTIL ALL FINAL INSPECTIONS HAVE BEEN COMPLETED AND APPROVED,
THE USE OF THE POOL IS NOT DEEMED TO BE SAFE.
