#### **OTHER REPORTS**

**Supervisor Maerten** reported that the sales tax collected for August 2022 was \$189,876.14. This is an increase of \$33,122.49 when compared with August 2021. The year to date received for 2022 is \$1,509,492.23 which is an increase of \$264,081.44 from 2021.

Supervisor Maerten also stated that the Town Board supported engaging with an attorney to assist with the potential abandonment of the Bear Ridge Cemetery (east of Campbell Boulevard). A meeting was held on October 8, 2022 with the current members of the Bear Ridge Cemetery Association which resulted in new leadership who will be taking over the duties for the cemetery.

**Councilman Leible** presented the Town Board with pictures taken at Nine Mile Island and expressed his concerns over the terrible condition of the property. He recommended sending the Building Department over to the property to close it down until the property is cleaned up. He also commented on the condition of the pools and the fact that the Town is subleasing to a day camp.

# Councilman Evchich had nothing to report.

Councilman Hickman reported that he had participated in the Pendleton Community Faire and Business Expo which was recently held saying that it was a nice event. He spoke with many people about Household Hazardous Waste and some events coming up. Mr. Hickman also stated that he is interested in pursuing a credit card to be used for Town business mentioning that he had a conversation with the Town Clerk from Wilson regarding their policy. He would like to further discuss this option with the Town Board.

**Councilman Lombardo** stated the he also attended the Pendleton Community Faire and Business Expo and thanked Jim Sobczyk for putting on the event. Mr. Lombardo also thanked those that came out and helped the Historical Society move items from the buildings to the storage container. He also stated that he is interested in pursuing the Town credit card and would like to also consider purchasing EZPasses for the Town vehicles.

Attorney Joerg had nothing to report.

**Engineer Britton** stated that he would comment on some items during the New Business portion of the meeting.

**Budget Officer Maturski** reported that he will be speaking during the Budget Session which will take place after the Regular Meeting.

### **DEPARTMENT HEADS**

**Town Clerk Maurer** reported that she received and posted monthly reports from the Building Inspector/Code Enforcement Officer, Town Engineer, and the Water & Sewer Department. Also posted are the Town Clerk and Water & Sewer Collection reports for September. She also stated that over 200 renewal letters were sent out for the additional refuse tote service for 2023. Mrs. Maurer also reported that she provided the Town Board and Department Heads with the 2023 Tentative Budget on September 28, 2022.

**Highway and Water/Sewer Superintendent Fischer** reported that the new salt shed is fully erected and they have already loaded 300 tons of salt in it.

WHEREAS, a residential construction project has been approved adjacent to Campbell

Boulevard in the Town of Pendleton known as the Meadows at Pendleton North Subdivision; and

WHEREAS, approved construction plans for this project include various stormwater management features and structure which require ongoing maintenance performed by the Town of Pendleton Highway Department; and

WHEREAS; public hearings were scheduled, advertised, and held on November 11, 2019 to receive public input for the proposed new Stormwater District for The Meadows at Pendleton North Subdivision and the District fee; and

WHEREAS, establishment of a Stormwater District and annual fee for this project is necessary to ensure funding for future maintenance.

NOW, THEREFORE BE IT RESOLVED, by the Town Board of the Town of Pendleton on this 10th day of October 2022 that a Stormwater District shall be established for the Meadows at Pendleton North subdivision.

FURTHER, BE IT RESOLVED, that an annual fee is established to be \$65.00 per lot annually. This resolution shall take effect immediately.

## Pendleton Solar – Community Host Agreement

Supervisor Maerten began by explaining that there is currently one solar farm on Bear Ridge Road and another still under construction on Donner Road run by the same solar company. He stated that a Community Host Agreement has been proposed in which the Town would receive twice as much than if the property were subject to Town tax and the payment would be made up front rather than over a period of 15 years. A conversation regarding this matter took place between the Town Board, the Town Attorney, and the Town Engineer. The Town Attorney recommended that this agreement would be in the Town's best interest.
