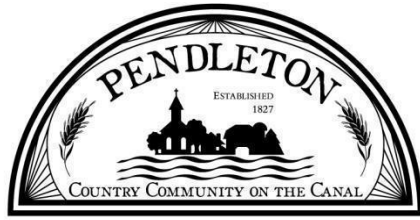

At the monthly meeting of the Town Board of the Town of Pendleton, Niagara County, New York, held in the Board Room at the Town of Pendleton Town Hall, 6570 Campbell Boulevard, Lockport, New York, 14094 at 7:00 p.m. on October 10, 2022.

**Resolution Authorizing Advertisement for Pendleton Town Park Site Improvements**

**WHEREAS**, the Town of Pendleton has been awarded grant funding for Town Park improvements, including installation of a splash pad and lavatory facilities; and

**WHEREAS**, the Town of Pendleton has been awarded grant funding for the construction of a community center to be located in the Town Park; and

**WHEREAS**, work focused on planning and design for these park projects continues and it has been determined that infrastructure improvements are necessary prior to construction of these facilities; and

**WHEREAS**, plans for park infrastructure improvement and corresponding public notice have been prepared by the Town Engineer and presented to the Town Board for consideration.

**NOW, THEREFORE BE IT RESOLVED**, by the Town Board of the Town of Pendleton on this 10<sup>th</sup> day of October 2022 that the Town Clerk is authorized and directed to publish the public notice for the Pendleton Town Park Splash Pad Site Improvements.

**FURTHER, BE IT RESOLVED**, that bidding materials will be made available on October 13, 2022 and all bids are to be submitted to the Town Clerk by 11:00 am local time on October 27, 2022, with the bids publicly opened and read aloud at 11:00 am.

**FURTHER, BE IT RESOLVED**, that final contract award will be made by resolution of the Town Board on a meeting subsequent to bid opening.
