**Facility Description:** Applicant applied to the New York State Office of Renewable Energy Siting (Office or ORES) for a permit pursuant to Executive Law § 94-c to construct and operate a 100 megawatt (MW) solar energy facility located in the Towns of Cambria and Pendleton, Niagara County.

## <u>Prior Combined Notice of Availability of Draft Permit Conditions, Public Comment Period</u> and Public Comment Hearing, and Commencement of Issues Determination Procedure:

Applicant filed the application with the Office on December 1, 2021. A notice of complete application was issued on August 2, 2022 (see <u>https://ores.ny.gov/permit-applications</u>, click on Project DMM Matter Number 21-02104, item no. 44).

ORES staff published draft permit conditions on October 3, 2022. The draft permit conditions may be accessed at <u>https://ores.ny.gov/permit-applications</u>, click on Project DMM Matter Number 21-02104, item no. 47.

On October 3, 2022, the ORES Office of Hearings issued a combined notice of availability of draft permit conditions, public comment period and public comment hearing, and commencement of issues determination procedure (Combined Notice). The Combined Notice scheduled a public comment hearing pursuant to 19 NYCRR part 900 to hear and receive unsworn comments from the public will be held at the **Cambria Volunteer Fire Company**, **4631 Cambria Wilson Road, Lockport, NY 14094 on Tuesday, December 13, 2022, at 5:00 p.m**. The Combined Notice also established a deadline of December 23, 2022, for the filing of written public comments and other deadlines for the issues determination procedure. <u>Notice of Additional Public Comment Hearing</u>: PLEASE TAKE NOTICE THAT pursuant to this Notice of Additional Public Comment Hearing, a second public comment hearing to hear and receive unsworn comments from the public will also be held at the Cambria Volunteer Fire Company, 4631 Cambria Wilson Road, Lockport, NY 14094 on Wednesday, December 14, 2022, at 6:00 p.m.

All persons, organizations, corporations, or government agencies who may be affected by the facility are invited to attend the hearing and comment on the application and the draft permit conditions. Lengthy comments will not be accepted and instead should be submitted in writing. Equal weight will be given to both oral and written comments. To ensure that all interested persons have an opportunity to speak, the Administrative Law Judge (ALJ) may limit the time available for oral comments to three (3) minutes per person. The public comment hearing will be transcribed for inclusion in the administrative record.

It is not necessary to provide comments at both the December 13 and the December 14 hearings. At the December 14 hearing, preference will be given to speakers who did not speak at the December 13 hearing.

The hearing location is reasonably accessible to persons with a mobility impairment. Interpreter services shall be made available to deaf persons, and English language translator services shall also be made available, at no charge for either service, upon written request to Chief ALJ James T. All requests must be received no later than 4:00 p.m. on Tuesday, November 29, 2022.
