In accordance with the Invitation to Bid, sealed bids for the referenced project were opened and publicly read aloud at 10:30 a.m. on November 1, 2022, at the Town of Pendleton Clerk's Office.

A total of eight (8) bids were received. Nussbaumer & Clarke, Inc. (Nussbaumer) has carefully reviewed all bids and found no math, or clerical errors in the submitted proposals. Enclosed for the Town's use and information is one (1) copy of the tabulation of bids. The bid tabulation is summarized as follows:

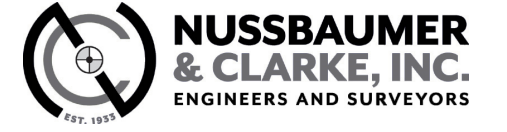
