#### **OTHER REPORTS**

**Supervisor Maerten** reported that the sales tax collected for October 2022 was \$187,960.33. This is an increase of \$45,956.75 when compared with October 2021. The year to date received for 2022 is \$1,941,054.62 which is an increase of \$335,610.61 from 2021.

Supervisor Maerten also thanked the staff at Town Hall and Department of Public Works for all of the hard work they did organizing and setting up for the 2022 Christmas Tree Lighting event that was held on December 2, 2022. He said that everyone did a great job and over 200 people attended. Mr. Maerten remarked that next year's event will hopefully be held at the new Community Center.

Councilman Leible had nothing new to report.

**Councilman Hickman** thanked Recreation Director Joelle Lange for putting together a winter recreation program proposal. He also thanked the Recreation Committee and welcomed new member Candice Black. Mr. Hickman also reported that he is working on a town credit card policy and will forward to the Board for their review once it is completed. Councilman Hickman thanked all involved in the Christmas Tree Lighting event and wished all a Merry Christmas.

**Councilman Lombardo** reported that he is still working with Mike Zimmerman from the Nine Mile Island Youth Camp committee regarding the issues that have been brought up recently. He will share updates with the Board as he receives them. Lastly, he stated that he met with volunteers from the Pendleton Farm & Home Days to gain a better understanding of the event which will help with future decisions.

**Attorney Joerg** answered a question regarding the rescinding of Resolution #191-20 which was asked earlier by a resident.

**Engineer Britton** provided updates on the following projects: Water Tower Painting, Bear Ridge Solar Project, Jacus Subdivision, SAM Grant for the Emergency Generator, and the Town Park Improvements. He also stated that he intends to have the documents ready to advertise the bidding process for the new Community Center by the January 9, 2023 meeting, pending Town Board approval.

Supervisor Maerten added that the New York State Office of Renewable Energy Siting (ORES) will be holding two public hearings to receive comments from the public regarding the Bear Ridge Solar Project, at the Cambria Volunteer Fire Company, 4631 Cambria Wilson Road, Lockport, NY 14094 on Tuesday, December 13, 2022, at 5:00 p.m. and Wednesday, December 14, 2022, at 6:00 p.m.

## **DEPARTMENT HEADS**

**Town Clerk Maurer** reported that she received and posted monthly reports from the Assessor, Building Inspector/Code Enforcement Officer, Engineer, and the Water & Sewer Department. Also posted are the Town Clerk and Water & Sewer Collection reports for November. She also provided an explanation as to why the Town Hall's phones and internet have been out of order for the last several days, stating that it was due to an error made by Spectrum. The phones at the DPW are also out of order due to damage caused by the previous week's windstorm. She is hoping that this issue will be fixed on Tuesday. Mrs. Maurer also spoke about the Christmas Tree Lighting event stating that it went very well and thanked all those that participated. Lastly, Mrs. Maurer informed the Board that she recently completed the requirements and received recognition as a Registered Municipal Clerk by the New York State Town Clerks' Association.

**Deputy Water & Sewer Superintendent Bair**, attending in place of Highway/Water & Sewer Superintendent Fischer, reported that the staff has been preparing for winter and cleaning up the roads after the recent snowfall. They also removed a time capsule from in front of the Historical Building which will be given to the Historical Society to be kept safely until it can be put back in the ground. He also stated that they are preparing for the demolition of the Historical Building/Log Cabin.

**Building Inspector Diedrich** had nothing to report.

**Assessor Valentine** stated that he is working on property transfers and continuing to update the RPS software with new data. He reported that a fair amount of exemption applications has already been received and that his office is helping residents through this process. Lastly, he noted that the updated tax roll was submitted to Niagara County Real Property.

## **RESOLUTION 249-22**

## ESTABLISH WATER LINE RESERVE

WHEREAS, the Town of Pendleton owns, operates, and maintains infrastructure to supply water for the residents and property owners of the Town; and

WHEREAS, it's in the best interests of the Town of Pendleton to establish a reserve for the accumulation of funds for the upkeep and replacement of water lines essential for the supply of water within the Town.

NOW, THEREFORE BE IT RESOLVED, that pursuant to Section 6-c of the General Municipal Law, as amended, there is hereby established a capital reserve fund to be known as the "Water Line Reserve Fund" (hereinafter "Reserve Fund"). The purpose of this Reserve Fund is to accumulate moneys to finance costs associated with the placement, replacement, and repair of water lines.

BE IT FURTHER RESOLVED, the chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The chief fiscal officer may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Town of Pendleton. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Town Board a detailed report of the operation and condition of the Reserve Fund. Except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of the Town Board and such additional actions or proceedings as may be required by Section 6-c [6-g] of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 4 of Section 6-c [subdivision 7 of Section 6-g].

BE IT FURTHER RESOLVED, that moneys specifically detailed in the approved 2022 budget may be transferred to this Reserve Fund.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.

#### PUBLIC REMARKS/COMMENTS

A resident asked when the Modern Disposal newsletter and calendar would be available. Town Clerk Maurer explained that they will be mailed out by Modern Disposal directly and that she will also post them online once she receives an electronic copy from the company. The same resident also asked about the vacancy which she noticed on the Town Board. Supervisor Maerten explained that Councilman Evchich had resigned the previous month and also explained the application and appointing process noting that letters of interest have been received and an appointment could be done as soon as the January meeting.

Another resident informed the Board that the decorative Town of Pendleton sign on Campbell Boulevard that was damaged by a contractor was recently replaced.

A third resident thanked Town Attorney Joerg for his answer to her earlier questions and reminded the Board that she is still awaiting a determination on her FOIL appeal.

Lastly, another resident asked for the time and dates of the public hearings which were adopted in the resolutions earlier in the meeting. Supervisor Maerten explained that they will be held prior to the meeting on January 9, 2023, beginning at 6:50 p.m.
