A Regular Meeting of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, NY, on the 14th day of August 2023 at 7:00 p.m. The meeting was preceded by a Public Hearing.

PUBLIC HEARING

PUBLIC HEARING - PROPOSED LOCAL LAW NO. XX OF 2023 – REAL PROPERTY TAX EXEMPTION FOR VOLUNTARY FIREFIGHTERS AND VOLUNTARY AMBULANCE WORKERS

The notice for the Public Hearing was published in the Lockport Union Sun & Journal on August 8, 2023 and on the Town's website.

Supervisor Maerten opened the Public Hearing at 7:05 p.m.

The purpose of this public hearing is to consider and adopt a Local Law to amend Chapter 224 of the Town of Pendleton Code at Section 224 applicable to the real property tax exemption for voluntary firefighters and voluntary ambulance workers in accordance with §466-a of the New York State Real Property Tax Law. Copies of the proposed Local Law were made available for public viewing at the Town Hall and on the Town's website.

Town Clerk Maurer explained that numbering of the sections of the proposed Local Law was incorrect and would have to be revised before the law is adopted.

Councilman Lombardo stated that he will abstain from voting because he is an active member of the Wendelville Fire Company. Councilman Leible stated the same.

Deputy Supervisor Mark Walter read a letter that was submitted by the Wendelville Fire Company in support of this law.

Councilman Buechler asked for clarification on the difference between this proposed exemption and the tax credit that volunteers are able to apply for already. Assessor Valentine provided a brief explanation and stated that the choice would need to be made by the individual.

There were no other questions or comments.

Motion made by Councilman Leible, seconded by Councilman Hickman, to close the Public Hearing at 7:11 p.m. Motion carried.

OTHER REPORTS

Supervisor Maerten reported that the sales tax collected for June 2023 was \$241,723.74. This is an increase of \$6,350.10 when compared with June 2022. The total tax collected to date for 2023 is \$1,203,798.86 which is an increase of \$274,224.65 from 2022.

Councilman Leible reported that the newsletter articles are due on the 20th of this month because there will be some time sensitive articles which need to be published a little earlier than usual. He also mentioned that the Pendleton Veterans Association approached him with questions about needing more space to hang the Hometown Heroes Banners. Mrs. Maurer added that 45 applications have been received so far.

Councilman Hickman reported that he will have the final bids for rugs, Town Hall landscaping, and fertilization finalized soon and will present them to the Board for review. He also thanked the Board members for their comments on the park policy draft, the potential Recreation Department position, and the proposed credit card policy.

Councilmen Lombardo had nothing new to report.

Councilmen Buechler had nothing to report.

Attorney Joerg had nothing to report.

Engineer Britton provided a brief report on the Community Center Project. He said that the project is moving forward and that a Notice to Proceed was issued in July 2023. He also stated that his firm has issued a request for proposals to provide Third Party Special Inspections. Lastly, he commented on the Emergency Generator Project stating that the generator is on target to arrive in January 2024.

DEPARTMENT HEADS

Town Clerk Maurer provided an update stating that the monthly reports from the Assessor, Building Inspector, Engineer, Town Clerk, and Water & Sewer Collection have been received and posted online along with the meeting agenda. She also informed the Board that the annual fees for the "additional refuse tote service" will now be added to the property owner's Town/County tax bills. Residents have until September 30th each year to cancel the service for the following year.

Highway and Water/Sewer Superintendent Fischer began by saying that he received a very nice compliment from a Bear Ridge Road resident saying how professional and responsible Water & Sewer Department employees, Lucas Frew and Kevin Johnson, were while repairing a sewer break on his property. Mr. Fischer continued by reporting on some of the activities his crew had been working on in July including off road mowing and ditching, keeping up with the parks, and replacing pipe on Oakwood Drive, to name a few.

ADOPTION OF LOCAL LAW FOR PROPERTY TAX EXEMPTION LOCAL LAW NO. 04 OF THE YEAR 2023

Town of Pendleton, County of Niagara County, State of New York

Title: Volunteer Firefighter and Volunteer Ambulance Workers Real Property Tax Exemption

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF PENDLETON, COUNTY OF NIAGARA AS FOLLOWS:

Section 1. Purpose

New York State Real Property Tax Law was amended by the Laws of 2022, Chapter 670 adding a new provision §466-a. This section provides for an up to ten percent partial real property county tax exemption for the assessed value of the primary residence owned by a qualified and certified enrolled member of the incorporated volunteer fire company, fire department or incorporated volunteer ambulance service. The intent of this Local law is to permit the partial real property tax exemption for such qualified enrolled members of said emergency services organizations for real property taxes imposed by the Town of Pendleton. Members of volunteer fire departments and ambulance corps provide valuable services to the residents of the Town of Pendleton. In order to be certified and recertified, such volunteers must undertake numerous hours of training on their own time and often at their own expense. The purpose of this exemption is to maintain the ranks of the volunteers while encouraging other volunteers to join.

Section 2. Authority

Pursuant to Chapter 670 of the Laws of 2022, effective December 9, 2022, the state Real Property Tax Law was amended by adding a new §466-a authorizing local governments including towns to enact by local law, ordinance or resolution such partial tax exemption for Town real property taxes to qualified enrolled members of said emergency services organizations, following public hearing.

Section 3. Requirements

Pursuant to Section 466-a of the New York State Real Property Tax Law, real property owned by an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service or such enrolled member and spouse residing in The Town of Pendleton, County of Niagara shall be exempt from taxation to the extent of ten percent (10%) of the assessed value of such property for Town of Pendleton purposes, exclusive of special assessments. A ten percent (10%) exemption from taxation shall not be granted to an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service residing in the Town of Pendleton unless such enrolled member and/or spouse satisfies the following:

- 1. The applicant resides in the Town of Pendleton which is served by such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service; and
- 2. The property is the primary residence of the applicant; and
- 3. The property is used exclusively for residential purposes; provided however, that in the event any portion of such property is not used exclusively for the applicant's residence but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this section; and
- 4. The applicant has been certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or voluntary ambulance service as an enrolled member of such incorporated volunteer fire company, fire department or voluntary ambulance service for a period of five years of service
- 5. The applicant must file a certificate from his or her qualifying organization that he or she is an enrolled member. Such certification of membership must certify that the member received credit under a service award program defined by Article 11-A, 11-AA, 11-AAA or 11-AAAA of the General Municipal Law for the period of service claimed in the application.

Section 4. Lifetime Exemption

Any enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service who accrues more than twenty years of active service and is so certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, shall be granted the ten percent

exemption as authorized by this section for the remainder of his or her life as long as his or her primary residence is located within such the Town of Pendleton.

Section 5. Spousal Exemption Where Member is Killed in the Line of Duty.

Un-remarried spouses of volunteer firefighters or volunteer ambulance workers killed in the line of duty

- 1. An exemption granted under this Local law shall be continued, and a pre-existing exemption shall be reinstated, where the exemption was previously claimed by an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service to such deceased enrolled member's unremarried spouse if such member is killed in the line of duty provided, however that
 - a. Such un-remarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service as an un-remarried spouse of an enrolled member of such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service who was killed in the line of duty; and
 - b. Such deceased volunteer had been an enrolled member for at least five years; and
 - c. Such deceased volunteer had been receiving the exemption prior to his or her death.

Section 6. Spousal Exemption Where Member is Deceased.

Un-remarried spouses of deceased volunteer firefighters or volunteer ambulance workers

- 1. An exemption granted under this Local Law shall be continued, and a pre-existing exemption shall be reinstated, to an un-remarried spouse of a deceased enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service provided however that
 - a. Such un-remarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service as an un-remarried spouse of a deceased enrolled member of such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service; and
 - b. Such deceased volunteer had been an enrolled member for at least twenty years; and
 - c. Such deceased volunteer and un-remarried spouse had been receiving the exemption for such property prior to the death of such volunteer

Section 7. Application for Exemption

- 1. Application for such exemption, along with the certificate of membership defined above, shall be filed with the Town of Pendleton assessor on or before the taxable status date on a form as prescribed by New York State
- 2. Certification shall be required for any period of time claimed by an applicant that is not already on file with the applicable town assessor.
- 3. The assessor shall review the application and certification to ensure they have satisfied the requirements of this law.

Section 8. No Diminution of Benefits

No applicant who is a volunteer firefighter or volunteer ambulance worker who by reason of such status is receiving any benefit under the provision of Article 4 of the state Real Property Tax Law on the effective date of this Local Law shall suffer any diminution of such benefit because of the provisions of this Local Law.

Section 9. Severability

If any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent

jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 10. Effective Date

This Local Law shall be effective upon its filing with the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

FURTHER, BE IT RESOLVED, that the Highway Superintendent is authorized to sell surplus pavement millings to any individual or entity at a cost of \$100.00 per load, with delivery limited to the Town of Pendleton.

FURTHER, BE IT RESOLVED, that prepayment is required for all sales of pavement millings. This resolution shall take effect immediately.
