BE IT RESOLVED, by the Town Board of the Town of Pendleton on this 25th day of September 2023, that the proposal received from Life by Design related to material and color selections for the community center project, as presented to the Town Board, is accepted. This resolution shall be effective immediately.

The 2024 Tentative Budget and Exemption Impact Report was presented to the Town Board by the Town Clerk prior to the meeting. Both documents are also posted online for public viewing.

Next, Yvonne Vivian and Candice Black, from the town's Recreation Committee, spoke to the Town Board about the need for new and additional sports equipment, storage for this equipment and other recreational supplies and gave a short presentation to the Town Board regarding upcoming winter events that they will be sponsoring. Mrs. Vivian also reported that she has found some potential grant funding, up to approximately \$60,000.00, that might be available to the town for recreational activities. She requested permission to work with the town's grant writer and apply for these funding opportunities. They also spoke about the town's annual tree lighting event and proposed a town wide "festival of lights" to go along with that event. Mrs. Vivian will give the Town Clerk information to advertise for both of these occasions. Supervisor Maerten asked if town baseball was in the works for next spring and suggested that they begin advertising and registration soon.

Councilman Lombardo reported that the Boy Scout Council has been working directly with the town's insurance agent to ensure that they have the required coverage necessary to meet the terms of the Facilities Usage Agreement. A discussion also followed regarding the cleanup of the property at Nine Mile Island.

Councilman Buechler stated that Recreation Director Joelle Lange hopes to hire some older counselors for the Summer Recreation Program next year to avoid some of the issues she ran into with staff this summer. Supervisor Maerten recommended that we start advertising for these positions sooner than later. Mr. Buechler also mentioned that Mrs. Lange provided the parents with a questionnaire to complete regarding the summer program and will share the results with the Board.

Councilman Leible reported that the fire extinguishers at the Town Hall and Highway Garage have been inspected. He also said that he is working to get the lights outside of Town Hall fixed.

Next, a conversation took place with Engineer Britton regarding installing a door fob system at the community center. It is recommended to decide on this now before construction begins. The installation of ADA compliant handicap button/automatic door openers was discussed as well.

Town Attorney Joerg stated that he and Supervisor Maerten have been working on a proposed cable franchise agreement renewal with Spectrum Northeast, LLC, which will provide revenue to the Town of Pendleton. His recommendation is that this renewal agreement be approved and he suggested that a public hearing be held at the next Board meeting to allow for public input. He also asked Councilman Leible to include a notice in the next newsletter telling residents to contact the town if they do not have access to internet service.
