#### OTHER REPORTS

**Supervisor Maerten** reported that the sales tax collected for January 2024 was \$210,498.24. This is an increase of \$6,875.12 compared with January 2023. The year to date received is \$210,498.24 which is an increase of \$6,875.12 from 2023.

# Councilman Leible had nothing to report.

**Councilman Hickman** reported that there has been good activity with receiving applications for the positions of Recreation Director and Summer Recreation Director. He stated that the Town has also received several applications for counselors for the Summer Recreation Program. He and Councilman Buechler will be conducting interviews for the director positions soon.

**Councilmen Buechler** said that it is very exciting to see so many qualified candidates for the Recreation Director and Summer Recreation Director positions which will provide an opportunity for the Town to make a good selection.

**Attorney Joerg** had nothing to report.

**Engineer Britton** explained that the next round for reapplication for funding for the Campbell Boulevard Water Line Extension Project is in June. He is in the process of preparing the documentation for that application in hopes of being able to advance with that project. He also reminded everyone that there will be an interactive Public Informational Meeting, regarding the update to the Comprehensive Plan, on Wednesday, March 13, 2024 at 6:30 p.m. This meeting will be held at Town Hall and is open to all.

#### **DEPARTMENT HEADS**

**Town Clerk Maurer** reported that monthly reports were received from the Assessor, Building Inspector/Code Enforcement Officer, and Dog Control Officer. These reports, along with the monthly reports for the Town Clerk, Tax collection, and Water/Sewer collection, were posted online with the agenda documents. Mrs. Maurer informed the Board of the following monies received and collected in the month of February:

**Assessor Valentine** explained that March 1<sup>st</sup> was taxable status day for Pendleton and was also the last day to turn in exemption applications for the 2024 Tax Roll. He reported that approximately 300 exemption applications were turned in and that they will be in the process of reviewing them for the next four - six weeks prior to turning in the Tentative Roll to Niagara County.
