- 1.) The scope of materials shall include only materials set forth in the attached quotation from FBM which quotation is expressly incorporated made part of the purchase order between Buyer and FBM.
- 2.) Delivery to be F. O. B. jobsite, tailgate delivery unless otherwise stated in advance.
- 3.) Only manufacturer's warranties shall apply to goods purchased under this Purchase order.
- 4.) Any changes in the purchase order or change orders shall be provided in writing and shall give FBM reasonable time to complete the work in an efficient manner.
- 5.) FBM shall have no liability to Buyer for any delays caused by events beyond Sellers control, including but not limited to strikes, civil disorders, fire, floods, adverse weather conditions, labor difficulties, delays in transportation, shortages of materials, delays in approval and return of shop drawings or submittals, and delays in predecessor activities.
- 6.) Any and all credit extended pursuant hereto shall become a valid and binding account as stated unless FBM receives a written objection to any materials supplied under specific invoice within five business days after delivery. Such written objection shall state: (1) the date of delivery of the materials; (2) the invoice number of the purchase; (3) the items in question; (4) the date upon which the items in question will be returned to HBS. If the Buyer supplies such written objection, Buyer shall return items in question listed on the objection notice within five business days after the date of such objection. Provided that the materials have not been changed, altered, modified or damaged in any way, a refund, if due, less any applicable restocking & shipping charge's, will be credited to Buyer's account. If such supplies are not returned within said five day period, then any and all credit extended therefore shall become a valid binding account as stated and Buyer agrees that any and all rights to reject such goods or bring any claim or counter claim thereon shall be waived. Non-stock and special order items may not be returned for credit without prior written approval from FBM.
- 7.) Payment shall be made Thirty (30) days from the date of invoice unless otherwise stated on the invoice.
- 8.) Buyer shall not withhold any retainage from FBM.

- 9.) FBM may add a finance charge of 1 1/2% (18% annual) to any unpaid balance over one month past due. Buyer further agrees that in the event of default in payment, to pay any and all costs of collection including reasonable bank and attorney's fees. Suits, if necessary, shall be in accordance with and be filed in New York State in the courts located in Monroe County.
- 10.) Buyer shall provide, upon request, the legal description of the property, the name, address and representative of the owner. If a payment bond is required, upon request, a copy of the bond shall be provided.
- 11.) As proof of insurance FBM shall provide Buyer with a blanket insurance certificate upon request, however, FBM will not list Buyer as an additional insured.
- 12.) Buyer and his agent agrees to indemnify and hold harmless FBM, and it's representatives from any and all liability for any damage caused by moving delivery vehicle beyond limits of approved road or right of way.
- 13.) Any form of language wherein FBM purports to release Buyer, Owner, or design professional is hereby qualified by the following language whether or not FBM specifically adds the language: "This release shall apply only to labor and materials for which payment has been received in full by FBM; shall not apply to unbilled changes, to claims which have been asserted in writing or which have not yet become known to FBM; and shall be conditional upon receipt of funds to FBM account."
- 14.) All information and pricing contained with this quote are valid for the 30 days after the date on the quote. Thereafter, all prices and applicable charges are subject to change.


