April 15, 2024

A Regular Meeting of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, NY, on the 15th day of April 2024 at 7:00 p.m.

PUBLIC HEARINGS

PUBLIC HEARING #1 - PROPOSED LOCAL LAW NO. __ TO ADD SUBSECTIONS TO SECTION 235-4 A GENERAL PROVISIONS OF THE PENDLETON TOWN CODE

The notice for the Public Hearing was published in the Lockport Union Sun & Journal on April 5, 2024 and on the Town's website.

Supervisor Maerten opened the Public Hearing at 7:02 p.m.

The purpose of this public hearing was to allow public comment on a proposed Local Law to add the following subsections (6), (7) and (8) to the Pendleton Town Code Section 235-4 A General Provisions;

- (6) The North side of Beach Ridge Road for a distance of 150 feet East from the stop sign at the approximate intersection of Beach Ridge Road and Townline Road; and
- (7) The South side of Beach Ridge Road for a distance of 375 feet East from the approximate intersection of Beach Ridge Road and Townline Road; and
- (8) The East side of Townline Road for a distance of 150 feet North from the approximate intersection of Townline Road and Beach Ridge Road.

A copy of the proposed Local Law was made available at the Pendleton Town Hall and the Town of Pendleton Website.

Councilman Lombardo stated that he did not agree with the distances that were published. He would like to take additional time to research before making a final decision on this matter. Councilman Leible agreed and suggested that a decision is tabled until further review is completed. Supervisor Maerten also agreed that the first attempt to address this situation may have gone a bit too far and needs additional analysis.

Supervisor Maerten opened up the floor to the public.

Mr. Thomas Ferlito, owner of the Country Cottage Restaurant, spoke first. He stated that the unintended consequences of the proposed parking restrictions will negatively affect his business. Mr. Ferlito provided statistical data showing anticipated loss of revenue if these changes are approved. He asked that the Town Board consider the information he presented when making a decision on the parking restrictions. He also stated that he had been working with the Building Inspector for an alternative parking solution but it would be a costly project.

Mr. Gary Gilman of Beach Ridge Road spoke in favor of the proposed parking restrictions stating that the current situation is dangerous. He spoke directly to the owners of the Country Cottage Restaurant and requested that they encourage their customers to park further down the road, away from the intersection, until an alternative plan is in place.

Further discussion took place regarding how the measurements included in the proposed local law were determined.

Supervisor Maerten explained that the intent of the proposed local law has always been to address the concerns related to the blockage of the stop signs at that intersection and stated that further review will be conducted before the next meeting.

There were no other questions or comments.

Motion made by Councilman Leible, seconded by Councilman Lombardo, to close the Public Hearing at 7:15 p.m. Motion carried.

PUBLIC HEARING #2 - REZONING APPLICATION - CAMPBELL BOULEVARD PARCELS

The notice for the Public Hearing was published in the Lockport Union Sun & Journal on April 5, 2024 and on the Town's website.

Supervisor Maerten opened the Public Hearing at 7:15 p.m.

The purpose of the hearing was to allow public input on a request to rezone SBL 136.00-1-46.12 and 136.00-1-46.112 from the current mixed zoning. The proposed change includes SBL 136.00-1-46.12 being rezoned to Residential (R-2) for the entirety of the parcel and SBL 136.00-1-46.112 being rezoned to Light Commercial (CO-1) for the entirety of the parcel.

There were no public comments.

OTHER REPORTS

Supervisor Maerten reported that the sales tax collected for February 2024 was \$180,658.80. This is an increase of \$2,804.69 compared with February 2023. The year to date received is \$391,157.04 which is an increase of \$9,679.81 from 2023.

Councilman Leible stated that the deadline dates for submitting newsletter articles will be moved up to the 15th of the quarterly month in which they are due. He will provide an updated schedule to those who submit articles. Mr. Leible also reported that the Fourth of July celebration will include a magic show from 6:00 p.m. - 7:00 p.m., live music from 7:00 p.m. until the fireworks start at dusk, and food trucks.

Councilmen Lombardo had nothing to report.

Councilmen Buechler mentioned that there is a Special Election scheduled for April 30, 2024 to fill New York's 26th Congressional seat left vacant by former Congressman Brian Higgins. He also noted that due to redistricting the 26th Congressional District now includes parts of Erie and Niagara Counties.

Attorney Joerg had nothing to report.

Engineer Britton reported that the stormwater permit for the town will require some new action items. He is working with the Town Clerk, Highway Superintendent and Building Inspector to compile the information and gather documents required for this task. He also stated that a survey regarding the updates for the town's Comprehensive Plan will be publicized soon.

DEPARTMENT HEADS

Town Clerk Maurer reported that monthly reports were received from the Assessor, Building Inspector/Code Enforcement Officer, and the Engineer. These reports, along with the monthly reports for the Town Clerk, Tax collection, and Water/Sewer collection, were posted online with the agenda documents. Mrs. Maurer informed the Board of the following monies received and collected in the month of March:

She also stated that the 2024 tax collection in the Town of Pendleton ended on April 1, 2024 with a total of 97% taxes paid. The remaining unpaid taxes for the year were turned over to the Niagara County Treasurer's Office.

Highway and Water/Sewer Superintendent Fischer started off saying that he hopes that plowing and salting is done for the season. He then reported on some of the activities completed by the Highway and Water/Sewer Department in the month of March including stocking of salt in the salt barn, replacing plow stakes throughout the town, repairing plow damage to residential properties and making general repairs on trucks and equipment. He also reported that they continue to install culvert pipes in front yards, are cleaning drainage ditches and have removed fallen trees from the bike path. Lastly, Mr. Fischer stated that they have been working on cleaning up Nine Mile Island to prepare it for the summer season.

Building Inspector Diedrich provided kudos to Mr. Fischer stating that he has received far less calls this year about "wet yards".

Assessor Valentine reported that his office has be working on cleaning up exemptions and updating inventory and assessments due to property transfers.
