BOARD DISCUSSION

Councilman Buechler reported that the final Length of Service Award Program (LOSAP) report for the Wendelville Fire Company for this year has been completed and submitted to the Town Clerk.

Councilman Hickman stated that he recently met with Ed Dore from Dore Landscaping to discuss a proposal to extend the current landscaping maintenance contract. The proposed amendment includes an additional cleanup at the Town Hall property and added maintenance for the Pendleton Center trailhead.

Councilmen Lombardo and Leible reported that they will arrange for repairs to a malfunctioning furnace at Town Hall.

Councilman Leible added that he and Councilman Lombardo will participate in a walkthrough with Parise Mechanical to review the maintenance and upkeep of the equipment at the Community Center.

Town Clerk Maurer informed the audience that ConnectLife will hold a blood drive at Town Hall on Monday, November 4th. She also inquired whether the expenses for the Christmas Tree Lighting event have been approved so she can proceed with printing flyers for the Recreation Committee.
